Madison Region's 2019 Workplace Diversity & Inclusion Survey Findings

IMPROVING WORKPLACE DIVERSITY & INCLUSION PRACTICES

Building on the success of its groundbreaking Workplace Diversity & Inclusion (D&I) Surveys from 2015 through 2018, MadREP launched its fourth D&I Survey in early 2019. As with the earlier editions, this year's survey was used to capture quantitative and gualitative data about workforce demographics, supplier diversity programs, and community engagement while providing companies with a vehicle to self-assess strengths and opportunities relative to diversity in their workforce. The inclusion of a diverse workforce is vital to the sustained economic growth of the region, and assessing the progress of diversity and inclusion efforts by Madison Region employers is a critical step in improving our practices.

The survey was sent to a random sample of 1,864 employers (drawn from 7,969 organizations with 10 or more employees) between February - March 2019 and received 363 responses, for a confidence interval of plus/minus 5.03%. Nearly 94% of respondents based their answers on locations within the Madison Region, with representation from businesses in all eight of the region's counties. While companies of all sizes responded, 80% have fewer than 50 employees. Eightyone percent of responding entities are for-profit and 10% are nonprofit, with the remaining respondents from government, academia, or other.


More than 82% of respondents have been in operation for 11+ years, and more than 76% of respondents report revenue below \$5 million. Survey results represent a broad range of industries, with companies from all industry sectors responding.




MADISON REGION ECONOMIC PARTNERSHIP




